## **Guidelines for Contractors**

### **Subcontracting with Debarred or Suspended Persons**

Debarred or suspended persons or firms may not enter into contracts with Wisconsin Department of Transportation (WisDOT). Contractors participating in federally funded WisDOT projects must comply with federal guidelines\* in transactions with persons or firms who are debarred or suspended. Failure to abide by the federal guidelines may result in penalties.

Contractors must certify they will not knowingly enter into any subcontracts with persons who are debarred or suspended for a covered transaction. The guidelines, applicable to federally funded projects, provide an exemption for small-purchases from subcontractors of \$99,999 or less (this includes cash and its equivalents) of noncritical items.

In addition to the federal guidelines, WisDOT specifications\*\* require prime contractors to obtain written consent to subcontract any portion of a contract. When seeking consent to subcontract, prime contractors must disclose to WisDOT that the subcontract is to a debarred or suspended person and other relevant facts. Contractors should also consider the following when requesting consent to subcontract on federally funded projects with a debarred or suspended person or firm:

- WisDOT will not enter into any contract with a debarred or suspended contractor.
- The prime contractor seeking WisDOT consent to sublet with a debarred or suspended contractor shall disclose that it is seeking consent to contract with a debarred or suspended subcontractor.
- Subcontracts, regardless of size, with debarred or suspended persons who would have a critical influence or substantive control over the prime contractor (auditing services, construction inspection, quality assurance, etc.) will not be approved.
- The subcontract shall be in writing.
- If the subcontract with the debarred or suspended contractor is for a fixed amount, it shall not be more than \$99,999.
- If the subcontract with the debarred or suspended contractor is a unit-price contract, the parties need to anticipate any increase in quantities. The total price of the contract may not be more than \$99,999.
- The debarred or suspended person or firm may not sublet to the prime contractor for an amount of more than \$99,999 for each WisDOT contract.
- **No subcontracts or other arrangements for work greater than \$99,999 will be allowed for contracts executed prior to the termination date of the debarment.**
- The contractor shall comply with the terms of the written approved subcontract.
- If the subcontractor is certified as a Disadvantaged Business Enterprise (DBE), DBE credit is allowed.
- WisDOT is not responsible for any additional costs because the prime contractor enters into a transaction with a debarred or suspended subcontractor.
- WisDOT has the right to examine all books, records, documents and other data of the contractor and subcontractor relating to the subcontract.
- No exceptions will be granted.
- Failure to adhere to these restrictions may result in additional penalties.
